# 2. Executive Committee Report

- President:
  - o UCONN Budgets
    - Huge budget shortfall and UCONN has frozen hiring. As of now, it has not affected grad students, seems to be mostly class A or such like admins. This should not affect professors yet. This is due from grants being cut and other financial changes.
    - Will be joining an Emergency University Senate meeting regarding budget and will have more updates when see us.
  - o Travel
    - UCONN is putting a hold on travel. But strongly recommending using endowments for other purposes other than travel.
  - Grad Emergency Fund
    - Being evaluated and sent. There were 400 people before it closed.
       Seems most of them are being rejected. We can talk to grad school about that.
    - Main criteria seem to be it cannot supplement TA funding or GA funding. So not having summer funding does not seem to be an emergency according to the grad school. But if there was a cut of funding when expected summer funding, that is different and can be considered an emergency.

    - Have some students who seem to be having problems with Fall funding falling through and the President will be looking into that.

#### Events

- Requested \$20,000 for activities for Graduate students. Sending a formal request and will update soon.
- Constantly in touch with TSOS about PRs being rejected oddly or without reason or lots of inconsistency. TSOS stated they talk to staff about how to operate with GSS and streamline process and make it more consistent and fairer.
- Talked about a few other things with TSOS that they keep requiring posters, but normally only make when PR is official done and event will happen. So will touch on how to make that easier.

## Vice-President:

- VP duties
  - Have been working on document of expectations for Senate. So, it is more of an abridged Robert's Rules which is about who is allowed to speak and when. Give a guideline document so that all people grad students, senates, UConn administration, outsiders, etc.
  - Trying to make a standing rule of the Senate.
  - Pres: I would also recommend clarifying what issues forum is and what it is supposed to be used for. Issues are about issues that is affecting all graduate students—nothing personal or motivated against a singling out a person or small group of people.

### Activities

- Met with TSOS to help with fundraising methods with GSS so that more students can attend. The idea is that some grad students pay activities fee and some don't—we cannot have people who do not pay the grad student fee from benefitting from GSS. Will be looking to create a method to "opt-in" to paying the fee for the Semester.
  - Will make a proposal for this soon.
- Looking into priority entry or other passes to give various benefits.
   Looking into different options.
  - Making a proposal for this soon.
- Will also make it easier to see who pays the fee and who doesn't so we can check that to make sure we are only benefiting people who pay the fee.
  - We can also rent a credit card reader so people can bring a +1 person, and they can pay for them right then and there on the spot.

#### • Treasurer:

- o All bills have been paid. No hanging bills.
- Working on TII and TIII funding forms. TII form is ready and already sent training slides to TSOS and all training documentation.
- Have been a lot about parking pass reimbursement got bill for former VP AY 24-25 so should send that soon.
- Sent an email to Finance Committee requiring summer funding and making sure everything complied. TSOS said "TSOS has done a formal audit, but all things were done under proper procedures".
  - So, Summer 2023 was done in accordance to all GSS Policies,
     University, and State and Federal Policy as confirmed by TSOS.
- All documents up to date and everything has been documented and up to date.
- o Pres: TSOS Said there will be a meeting with compliance office and such.
- Will sign a contract with TSOS, but we need to have confirmation from the Senate before doing such.
- O Pres: Will be a meeting with GSS, TSOS, and Compliance Office. They will create a scope of their audit and a report. Will discuss the entire procedures for the Report, which will take some time. Probably until end of Fall 2025.
- o GSS asked for a formal audit to check on and investigate all policies and committees for a formal audit into GSS money and how it is handled. Will also provide some non-binding recommendations.
- Audits and PRs
  - Pres: The problem is everything changes and past GSS people keep saying they have no money. We are making a formal process to make sure everything is streamlined, transparent, and straight forward.
  - Many PRs seemed to have different standards and rules across TSOS. So, an audit helps streamline the process and exactly where the money goes.
- o An email should go out by Monday to send out TII trainings.

# • Communication Director:

- Writing minutes and documentation as normal.

- Working on the website. Hope to make a calendar of events by end of summer.
