c. Parliamentary Procedures

- ii. While any graduate student may attend or participate in GSS Senate meetings in person, during motions and the resulting discussion only Senators can participate. The only exception is executive sessions, called by the Senate, where only members of the body (i.e., Senators and E-Board members) are present.
- iii. Senate meetings are conducted in person. Special exceptions are granted only to off-branch campus Senators, who may attend online.

d. Conduct and Documentation

- i. Senate meetings are public, documented, and you represent your constituencies. Meetings are recorded and documented; there is no expectation of privacy except for voting in closed ballots or executive sessions.
 - 1. Representing your department means everything you say, vote on, or discuss during meetings reflects your department's stance as one of the five main UConn governing bodies.
 - 2. Constituencies may remove a Senator as their representative at their discretion.
 - 3. No side conversations are permitted. All remarks must be made directly to the main assembly while in session.
- ii. Senators must be recognized by the Chair unless serving a specialized role, such as assisting with procedures.
- iii. Debate or discussion must always relate to the motion or topic at hand. Broader discussion must remain relevant to graduate students represented by GSS. Motives or personalities may never be debated. Professionalism must be always maintained. Anyone engaging in any form of harassment or targeting will be removed from the meeting and reported to the appropriate governing bodies.

iv. Disruption or inappropriate behavior is not permitted. The Chair or Senate may remove individuals for failure to follow decorum. The Chair may adjourn or reschedule a meeting if decorum and parliamentary procedures break down. Any rescheduled meeting is mandatory and tied to Tier-II funding (for attendance requirements under Financial Policies).

e. TII Funding and Resources

- i. Training will be held this Friday. Attendance is not mandatory; however, important procedures for filing Tier-II funding requests will be discussed.
 - 1. All Tier-IIs are responsible for completing necessary procedures to ensure compliance with GSS and UConn policies for funding.
 - **2.** The Treasurer will review these procedures in depth during the meeting.
- ii. Each Tier-II must have a Senator to file for funding.
- iii. Funding requests must be submitted at least 40 calendar days in advance. Documentation for marketing and funding requests must also be submitted 40 calendar days in advance. Details are available here: https://gss.uconn.edu/funding-2-2/
 - iv. Any funding request not submitted in accordance with the official procedures (as listed on the website and in policies) will not be funded. All Tier-IIs are solely responsible for complying with correct funding procedures.
